On Saturday, we were treated to a docent-led tour of the Bayou Bend Museum, which houses artifacts from the American Revolution. After an enjoyable lunch, we listened to a presentation about the Gálvez statue project from a representative of the SAR Bernardo de Gálvez Chapter of Galveston and heard from the artist who was present. The National and State meetings were then conducted where chapter reports were presented by Governors present and read from statements of Governors who could not make the event. San Antonio Chapter Governor Joe Perez was voted in as Governor General and Houston Chapter Governor Richard Espinosa was voted in as State Governor. Later in the afternoon, we visited the Clayton Library where docents showed us the "Cuban Papers" and other documents relating to General Gálvez. Saturday evening, we enjoyed a delicious paella dinner on a large patio. Kudos to the Houston Chapter for a wonderful event.

# Battle of Baton Rouge

On Saturday, September 21, 2013, a special ceremony was conducted commemorating the 234<sup>th</sup> anniversary of the Battle of Baton Rouge, where General Bernardo de Gálvez defeated the British in 1779. The ceremony was next to the site of the original fort. About forty to fifty visitors were in attendance including members of the SAR, DAR, Canary Island Historical Society of Louisiana (CIHSL), journalism students from Louisiana State University and a Cub Scout group. The audience was dazzled by the many



Revolutionary War uniforms and ladies' colonial dresses. Granadero Clifford Normand gave a talk and was in uniform representing his ancestor Pierre Trepagnier, Second Lieutenant of the German Coast Militia, who was involved in the battle. His talk covered the tactics used by Gálvez in outsmarting British Colonel Dickson. ## Author of "Got Proof!" Wins High Award

Michael N. Henderson was recently awarded the James Dent Walker Award, the highest honor

bestowed by the Afro-American Historical and Genealogy Society for his book, "Got Proof! My Genealogical Journey Through the Use of Documentation". Mr. Henderson's book tells the fascinating story of his fourth generation great grandmother, Agnes Mathieu, a slave who gained her freedom by bravely petitioning the Louisiana courts to honor her freedom papers. She was assisted by the father of her children, with whom she maintained a 31-year relationship but was not able to marry because they were not of the same race. The man, who, in today's social norms would be considered her common-law husband, was a Frenchman named Mathieu Devaux, who served as an Artilleryman under the Command of General Bernardo de Gálvez. That is why the 1779 manumission (freedom paper)



was signed by General Gálvez, Governor of Louisiana. At right is Mr. Henderson holding his award with Barbara Walker, wife of the award's namesake. The Indiana Society Sons of the American Revolution has sent a resolution to the National Society SAR to give recognition to Spain's involvement in the American Revolution as follows:

"Therefore now be it Resolved, That the Indiana Society of the Sons of the American Revolution Petition the National Society of the Sons of the American Revolution to provide the same honors and recognition to Spain that it gives to France at all its activities and functions, including the display of the flag of Spain."

We don't have all the information yet on the status of the resolution but will keep the membership informed. The SAR and DAR have been instrumental for years in recognizing Spain's contributions to the American Revolution, especially the heroic efforts of General Bernardo de Gálvez.

# For The Space of Twenty Days...

#### Continental Marines Under the Command of General Gálvez

November is a special month for the U.S. Marines. "Resolved that two battalions of Marines be raised..." begins the resolution passed by the Continental Congress that created the Marines on November 10, 1775. The Continental Marines disbanded in 1783 and were recreated in 1798 as the U.S. Marine Corps, however, the Corps celebrates its birthday on November 10<sup>th</sup>. The Continental Marines wore green coats with high leather collars which gave them the nickname "Leathernecks". Granadero Bill Bowlin, who served in the Marine Corps, dons the uniform of the Continental Marines who served under the command of General Bernardo de Gálvez.



General Gálvez provided a ship to Continental Navy Captain William Pickles to replace one that was lost in a hurricane. The new schooner had the same name as the one it replaced, Morris. While Pickles was the Captain, Lieutenant Daniel Longstreet commanded the Marines on board. The crew of the Morris was ordered to harass the British at every opportunity on Lake Pontchartrain. For two years, the British sloop, HMS West Florida, had held command of Lake Pontchartrain. Then on September 10, 1779, the Morris encountered the West Florida and after a brief skirmish, Pickles captured the British war sloop and took possession of it. One Spanish report read, "It is unbelievable that he should have captured it" because the West Florida was much better equipped with more cannons than the Morris.

After the Battle of Lake Pontchartrain, Captain Pickles, on his new sloop West Florida, was given orders to join the Spanish fleet "for the space of twenty days or longer if necessary, or requested by the Commander in Chief of the Spanish fleet." This may be the first instance

of American troops serving under a foreign command.

Continental Marines fought bravely at the Battle of Mobile and later at the Battle of Pensacola, assisting General Gálvez in his Gulf Coast Campaign against the British.



#### Resolution passed by the Second Continental Congress on November 10, 1775:

"Resolved, T hat two battalions of Marines be raised consisting of one colonel, two lieutenant colonels, two majors, and other officers, as usual in other regiments; that they consist of an equal number of privates with other battalions; that particular care be taken that no persons be appointed to office, or enlisted into said battalions but such as are good seamen, or so acquainted with maritime affairs as to be able to served with advantage by sea when required; that they be enlisted and commissioned to serve for and during the present war with Great Britain and the colonies, unless dismissed by order of Congress; that they be distinguished by names of First and Second Battalions of American Marines, and that they be considered as part of the number which the Continental Army before Boston is ordered to consist of."
